ORDINANCE TO APPOINT ALTERNATE MEMBERS FOR BOARD OF REVIEW

SECTION I-TITLE AND PURPOSE

This ordinance is entitled the Town of Mishicot Ordinance to Appoint Alternate Members for Board of Review. The purpose of this ordinance is to provide, upon lawful removal of named members or members unable to serve for any reason, alternate persons to serve as replacements to the Board of Review for the Town of Mishicot.

SECTION II - AUTHORITY

The Town Board of the Town of Mishicot, Manitowoc County, Wisconsin, has the specific authority under s. <u>70.47 (1) (6m)(c)</u>. Wis. Statutes. to appoint alternate members to serve on the board of review when standing members are removed from individual cases.

SECTION III - ADOPTION OF AN ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, Pursuant to Section 70.47 (6m)(c) and Sec. 70.46 (1) of the Wis. Statutes, hereby provides for the appointment of alternates to serve on the Town Board of Review in the event a standing board member of the board of review is removed or unable to serve for any reason.

SECTION IV-- APPOINTMENTS

The Town Board of the Town of Mishicot, Manitowoc County, Wisconsin, by this ordinance, shall establish and maintain a public list of persons eligible and appointed by the Town Board to serve as alternate members of the Board of Review. The list shall be arranged and maintained by the Town Clerk in a priority order of probable and likely service as an alternate Board of Review member. The alternate, once notified, if he or she approves the appointment, and if the appointment would not violate s. 19.59, Wis. stats., shall then take the oath of office and act as a member of the board of review under s. 70.47 (6m) (c), Wis. stats.

The Town board may name as many alternates as it deems necessary to meet the statutory requirement that no less than 3 board members are needed to make a final determination of an objection to a property assessment.

SECTION V - EFFECTIVE DATE

The appointments made by the Town Board, kept on a separate list maintained by the Town Clerk, are for the Year 2018 Board of Review Proceedings and succeeding years until such appointments are changed by action of the Town Board and are effective on publication or posting of this ordinance.

The town clerk shall properly post or publish this ordinance as required under s. <u>60.80</u>, Wis. stats.
